

**TERMS AND CONDITIONS**

Wyoming Gas Company, ("the Company") is hereby requested to provide gas service at the location herein described (the "premises"), and to furnish, own and maintain metering and regulating equipment located on the premises. As a condition to such service, it is understood and agreed as follows:

1. All private service lines, piping, appurtenant facilities, and gas-burning appliances or equipment located on or within the premises, shall be owned, maintained and controlled by the Customer and/or premises' owner, in accordance with the Company's Rules and Regulations, and all other applicable laws and regulations. Except as otherwise required by law, the Company does not undertake to, or assume the obligation for, the inspection, testing, maintenance, or repair of equipment or facilities not owned by the Company.
2. The Customer agrees that the Company will have the right of access to the Customer's premises at reasonable times for the purpose of installing, reading, inspecting, testing, maintaining and repairing Company equipment, or for removing such equipment. The Customer herein grants to the company a permanent easement for the installation of distribution pipeline providing natural gas service to the premises and others in the area. This easement includes the right to construct, reconstruct, operate, maintain, inspect, test, repair, alter, replace, remove, survey and abandon the buried pipeline. The pipelines shall be buried at sufficient depth so as not to interfere with the ordinary use of the soil, provided, however, that the customer shall not, without written consent from the Company, build any structure upon the easement. The surface and all damages shall be restored to the reasonable satisfaction of the Customer.
3. The Customer shall hold the Company harmless from any and all claims or liability for damages arising from the construction and operation of service lines, equipment, or appliances located on the premises, or for interruptions in service.
4. The Customer agrees to abide by the Company's present and future Rules and Regulations, and other applicable laws and regulations as a condition of gas service. The Customer agrees to pay for gas service at the Company's established tariff rates, as amended from time to time, plus such other sales, use, excise and other taxes imposed on the gas service. The Company may require a deposit in accordance with the Company's Rules and Regulations.
5. The Customer shall provide a minimum 48 hour prior notice to the Company, in writing, when the Customer desires to discontinue service and will be responsible for all service to that location until written notice is received.
6. The Company's Rates, Rules and Regulations are available for examination at the Company's offices during regular business hours. You are encouraged to review the Company's Rates, Rules and Regulation prior to signing this application.

### APPLICATION FOR CONVERSION

Wyoming Gas Company is hereby requested to convert Customer's appliances from propane gas to natural gas service. By signing this application, Customer agrees to the following terms and conditions:

1. In order to conform to the Uniform Mechanical Code of Regulations, it may be necessary to change the orifices on the appliance(s), install necessary piping from the natural gas meter to the appliance(s), and the Customer may be required to install or replace necessary venting.
2. This agreement does not include the installation and/or replacement of new appliances or flue and structural modifications.
3. If upon inspection of Customer's premises and appliances, Wyoming Gas Company, in its sole judgement, determines that conversion will not be mechanically possible or will be excessive in cost, then Wyoming Gas Company is not bound by this agreement.

4. Nothing in this agreement shall supersede, nullify, limit or otherwise affect the terms and conditions contained in Wyoming Gas Company Service Application and Agreement.

5. Wyoming Gas Company agrees to perform the conversion within 30 days of service line installation; provided, however, that if Wyoming Gas Company, in its sole judgement, determines it is not feasible to perform the conversion within that time period, Wyoming Gas Company shall so notify the Customer and Wyoming Gas Company shall not be liable for the failure to complete the conversion within the 30 day time period. There will be no charge for extension of the service line.
